

Beachwood Club Rules & Regulations

Rules and regulations are for the protection and benefit of all members and guests. These rules have been established to assure safe and sanitary operation of the Club's facilities.

Parents, children, and guests are required to observe all rules and regulations of the Club. The Club Manager, lifeguards, and other employees are responsible for the enforcement of these rules without prejudice. Please make their job easier by following their directions. Failure to comply with these rules could be sufficient cause for immediate suspension of club privileges for the offending member at the discretion of the Club Manager, and may also be considered sufficient cause for cancellation of Club membership by the Board of Directors.

A. ENTERING CLUB GROUNDS

1. Drive slowly and park in designated areas only.
2. Place all bikes and scooters in the bike area.
3. Members must identify themselves at the entrance and show identification if so requested; all members and guests of members will be signed in by the employee stationed at the desk.
4. A "Membership Family," for purposes of a Beachwood club membership, is defined as one or two adults and any children aged 24 years and younger permanently residing at one household at a particular address. Adult children aged 25 and over, or any other adult family members such as grandparents, whether or not permanent residents of a Membership Family household, may use the club as a guest under the rules established. For purposes of this subsection, an adult child's age shall be the child's age on the date the club opens for general swimming and tennis use in a particular calendar year. At the club's discretion, the Beachwood Board or staff may ask Membership Families to provide proof of age and residence via a driver's license or student ID, and/or provide a photograph, for any individual purported to be a member of a Membership Family for verification purposes.
5. Members shall ensure that their Membership Family members are accurately reflected on their membership profile in the Beachwood system, which is accessible through the Beachwood Portal. Members are expected to have a profile photograph in the Beachwood system for each Membership Family member, and if one is not on file the office staff will request such photo when the member enters the club.
6. Members must sign and pay for guest's fees at the office. The member signing in the guest must be 16 years of age or older. Guests must be accompanied by the sponsoring member at all times. A guest may visit the club no more than five (5) times in a calendar month, regardless of the sponsoring member accompanying the guest.
 - Guest fee policy: Credits may be purchased for \$5 or 10 for \$40 on the website. 1 credit per child guest that is 15 years old and younger. 1 credit

per adult Monday through Thursday. 2 credits per adult Friday-Sunday. On holidays (Memorial Day, 4th of July, and Labor Day), it is 3 credits for adult guests and 2 credits for children guests.

7. In order for a child aged 12 to 15 to be at the club without a supervising adult, a parental consent form needs to be filled out, found on the website. The online form will require parent/guardian acknowledgement. Children under 12 years of age may not be left at the club without a supervising adult.

B. SPECIAL MEMBERSHIP SITUATIONS:

1. a) A Membership Family may purchase a babysitter pass from club management for \$50 per calendar year season. This pass belongs to the Membership Family to use with up to three designated babysitters of such Membership Family. The individual using such babysitter pass to gain access to the club must be doing so in the capacity as a babysitter of the Membership Family, and, as such, the Membership Family's children must accompany the babysitter and the adult Members must not be present during the baby sitter's use of the club. Only one babysitter may use the pass at a time. **The babysitter must be 16 years old or older.**
2. b) Where a non-club member individual is a divorced parent of a child, and where such child and the individual's ex-spouse are members of the same Membership Family, such individual may use Beachwood as a guest of such child's Membership Family club membership solely where such individual accompanies such child under the rules established in paragraph B.3 above
7. All paid lessons, whether tennis or swimming, are to be provided by Beachwood personnel OR contracted by Beachwood to provide lessons. No ball carts shall be permitted on our courts other than those that are property of Beachwood and/or our pros. At no time shall a non-member(s) lesson prevent a Beachwood member access to the courts.
8. Use of the facilities for private parties is encouraged. A member must sponsor the party and be present at all times. All party dates must be cleared in advance with the Club Manager so as not to conflict with a previously scheduled event at the Club. Current guest fee policy shall apply for all non-members attending a private party. Note, the party must take place during scheduled hours of operation; the club will not extend regularly scheduled hours of operation in order to accommodate parties.
9. Any unusual situations pertaining to guest privileges should be submitted to the Club Manager for consideration and board approval.
10. There are no facilities for checking valuables. Do not bring them to the pool. The Club is not responsible for any loss or damage to personal property and will not reimburse any member or guest for any loss.
11. All children under 9 years of age using any portion of the pool must be accompanied by an adult member.
12. All swimmers must wear a swim suit. Clothes or cut-off jeans are not allowed in the pool at any time.
13. Use of the kiddie pool is restricted to children under 6 years of age and must be properly supervised unless special permission is obtained by the Club Manager.
14. Youngsters using float devices in the pool must swim with an adult.

15. During primetime (after 5:00 p.m. on weekdays and on weekends or holidays), lanes will be exclusively intended for lap swim only. During this time, adults (age 16 and over) shall have priority use of the lap lanes.

C. POOL HOURS

1. Pool hours will be established by the Club Manager with the approval of the Board of Directors.
2. The pool may be closed at the discretion of the Board for reasons of health, weather, or repair.

D. SAFETY RULES

To ensure the safety of all Beachwood members, the following rules will be enforced:

1. No Running on pool deck
2. No Diving over others
3. No Sliding
4. No Climbing of fences
5. No Dunking
6. No Boisterous conduct
7. No Pushing

Diving Area Controls:

The diving area is for recreational use. Any special use must be cleared in advance with the club manager.

- No goggles are allowed on the diving boards
- No loose jewelry is allowed on the diving boards.
- No flotation devices are allowed on the diving boards.
- No footwear is allowed on the diving boards.
- Only swimmers with appropriate swim attire are allowed on the diving boards.
- No diving or jumping toward the side of the pool.
- No hanging on the diving boards.
- No swimming in the diving area except to return directly to the pool side.
- No diving or jumping unless the area is clear.
- All divers must demonstrate competence to a lifeguard in order to use either diving board.
- Forward dives only, no twists, back, or inward dives.

No throwing of objects to divers.

E. HEALTH RULES

1. Persons with skin rashes, sores, abrasions, bandages, or infections shall not use the pool.
2. All bathers must shower before entering the pool.
3. No food, drinks (except bottled water) allowed in the deck area.
4. No glass on Beachwood Property
5. No smoking allowed on Beachwood Property.
6. No individual glass containers or glasses are allowed anywhere on the Beachwood property.
7. No children in diapers in the main pool.

F. TENNIS COURT AND PICKLEBALL RULES AND REGULATIONS

1. Hours: The tennis courts are open for play from 6AM – 11PM every day during the season.
2. Court Usage.
 - a) Courts are available on a first-come, first-served basis.
 - b) Special events can be authorized by the Tennis Professional and Tennis Committee on a case by case basis. When other members are waiting for courts, singles are asked to limit use to one hour and doubles are asked to limit use to 1 1/2 hours. Adults have priority over children less than 18 years of age after 5:00 PM Monday – Friday.
 - c) Courts may be assigned for group instruction, mixers, and tournaments as determined by the Tennis Pro/Staff or Committee.
3. Tennis Instruction.
 - a) The tennis staff has priority to use two courts for private lessons at any time during the season. Group lessons and clinics may require additional courts at certain times that will be posted by the Tennis Staff on the Beachwood website. The Tennis Pro/Staff has the discretion to utilize all courts for large groups of lessons and clinics.
 - b) All paid tennis lessons are to be provided by Beachwood personnel only. No ball carts shall be permitted on our courts other than those that are property of Beachwood and/or our pros.
4. Attire: Members and their guests must wear proper tennis attire. Swimsuits, bare feet, flip flops/sandals or the like are not permitted. Shirts must be worn at all times.
5. Guests: Members are required to sign in their guest at the front desk. Current guest fee policy shall apply.

The tennis professional/staff and the tennis chair have the responsibility and authority to enforce these rules.
